

NOTICE OF SPECIAL TOWN MEETING OF ELECTORS


Town of Clay Banks, Door County

Notice is hereby given that a special town meeting of the electors of the Town of Clay Banks, Door County, Wisconsin will be held at the town hall located at 6098 County Road OO, Sturgeon Bay, Wisconsin, on the 13th day of November, 2023, immediately following the completion of the Public Hearing on the proposed 2024 town budget, which begins at 6:00p.m., for the following purposes:

1. To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2023, *after* adjustments, by 3.535%, for a dollar increase of \$4,206.00.
2. To approve the 2023 total town tax levy (to be collected in 2024), pursuant to Wis. Stat. § 60.10(1)(a).

Town of Clay Banks, Door County
Resolution No. 23-10-01
Exceed Levy Limit

Whereas, the State of Wisconsin has imposed levy limits on town, village, city, and county levies for 2023 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602 limits the allowable local levy for 2023 to a percentage increase of no more than the greater of (a) zero percent of the 2022 payable 2023 adjusted actual levy as calculated under the state's levy limit law or (b) a percentage equal to the percent change in equalized value due to net new construction less improvements removed, which for the Town of Clay Banks is 0.461%;


Whereas, the town board of the Town of Clay Banks, Door County, believes that for the 2023 tax levy (to be collected in 2024) it is in the town's best interest to exceed the state levy limit as described above by a greater percentage than 0.461%;

Whereas, the Town of Clay Banks' 2022 payable 2023 adjusted actual tax levy was \$118,468, and further whereas the state law would limit this year's increase to \$546, for a total allowable town tax levy after adjustments for 2023 (to be collected in 2024) of \$118,985;

THEREFORE, the town board of the Town of Clay Banks, Door County does hereby resolve and order as follows:

1. The town board supports an increase in the town tax levy for 2023 that will exceed the amount allowed by the state levy limit.
2. The town board directs that the question of increasing the allowable town tax levy for 2023 (to be collected in 2024) by 3.535%, which would increase the town levy by \$4,206, for a total tax levy (after adjustments) of \$123,191 shall be placed on the agenda for the special town meeting to be held on November 13, 2023.
